AJourney of Faith

Marilen and Pete Recinto consider St. Ambrose Parish in Annandale their second home. They currently attend daily Mass and participate in several parish activities: the knitting club, bible study, rosary making, Knights of Columbus and Women of St. Ambrose. Their faith, joy and gratitude are infectious.

When Marilen and Pete met Father "Tuck" Horace Grinnell, he told them he couldn't have pursued his dream to serve the Lord without the financial assistance he received from the Bishop's Lenten Appeal (BLA). Upon hearing that, the Recintos' began annual support of the BLA and are considering including a gift to the diocese to support vocations in their Will.

Almost 30 years ago, Marilen suffered a stroke. Marilen used her stroke as an excuse not to attend Mass, though her devotion to Mary continued with the daily rosary. Before she knew it, more than 28 years had passed without going to Mass.

In 2015, Pete and Marilen participated in the CHC annual pilgrimage to the National Shrine Grotto of Our Lady of Lourdes at Mount St. Mary's University in Emmitsburg, MD. While praying at the Grotto, Marilen had no inkling that her faith was about to change and multiply.

After they returned home, the first change occurred when Marilen felt inspired to go to Church. She asked Pete "what time are we leaving for Mass" and since that moment has not missed daily Mass.

The second change was more unexpected. A fellow parishioner invited Marilen to submit an application to join the Order of Malta on their annual pilgrimage to Lourdes, France which is where the Virgin Mary revealed herself to Bernadette 18 times. During one apparition, Bernadette was instructed to dig in the mud until she discovered water and bathe in it. These waters are known to have miraculous healing powers for the sick and infirmed.

A self-confessed "type-A" personality, Marilen relinquished her worries and need for control on the pilgrimage. She truly felt free and let the peace of Lourdes seep through her. She knew she was on sacred ground and was happy there were no daily distractions. Since the caregiving duties for Marilen were taken care of by the Knights and Dames of the Order of Malta, Pete was able to more fully participate and enjoy the pilgrimage too.



During this journey, Marilen realized that each person at Lourdes, whatever their role, had their own cross to bear. She felt less alone in her suffering and welcomed feelings of humility, compassion and empathy. Marilen said she "brought Lourdes back with her," and is now more able to share in the sufferings of Christ.

After 48 years of marriage, Marilen and Pete are proud of their two children and five grandchildren. Growing up in the Philippines, they never could have imagined where the will of God would take them geographically or spiritually. They are happy and grateful their destination was the Diocese of Arlington!

Common Duties For an Executor of a Will

- Obtains a copy of the will and files it with the probate court
- Notifies banks, credit card companies and government agencies of the decedent's death
- Establishes a bank account for consolidating all assets and to pay ongoing bills
- Files an inventory of the estate's assets with the court

- Maintains properties until they can be distributed or sold
- Disposes of other properties
- Pays the estate's debts and taxes
- Distributes assets based on the instruction of the will
- Represents the estate in probate court

These are the most common executor duties. Depending on the size and complexity of an estate, there may be additional duties required. Please consult your attorney or tax advisor when naming your executor.

Making AGift Through Your Will



Gifts in wills known as bequests are the most common type of planned gift received by our Diocese.

- Bequests are revocable allowing you to modify or remove them if your circumstances change.
- A gift to the Church or your parish allows you to include charitable intentions without depleting assets you may need during your lifetime.

When considering a gift in your will, there are different types to consider depending on your situation:

- A general charitable bequest is used to give a specific dollar amount.
- You can choose a percentage of an asset or the percentage of your total estate.
- Another option is leaving the residue or remainder of your estate to the Church after all of your obligations are met.

Write Your Will

- 1. Call your attorney to schedule an appointment. If you need a referral, ask a friend or call the Diocese for a list of attorneys.
- 2. Prepare before you see an attorney.
- 3. Make a list of assets, obligations and instructions.
- 4. Consider a gift to the Diocese or your parish.
- 5. Keep your appointment and complete your planning and documents.

Your wishes will then be recorded. Your family will not be burdened with indecision since you have a valid Will.

Gifting Appreciated Stock is a Smart Thing to Do!

If you have highly appreciated securities and are reluctant to part with them, here are a couple of tax savings benefits to consider as you make your year-end gifts:

Tax Savings

If you are considering a cash gift of \$5,000 to the Diocese or your parish, consider giving \$5,000 worth of stock that you originally paid \$1,000 for. You then could use the \$5,000 cash you did not donate to repurchase shares in the same company.

By making a \$5,000 tax-deductible stock gift, you get an immediate tax deduction and avoid capital gains tax on the \$4,000 of appreciation. By repurchasing the stock you will maintain ownership but with a higher cost basis of \$5,000. If the stock increases in the future you will have less reportable gain, if ever sold.

Donor Advised Funds and or Gift Annuities

Another option for gifts of appreciated stock is to fund a **donor advised fund** which allows you to make a gift this year and then direct grants to charities in future years.

Or, you can fund a **charitable gift annuity** which provides guaranteed, fixed income for life based on your age.
